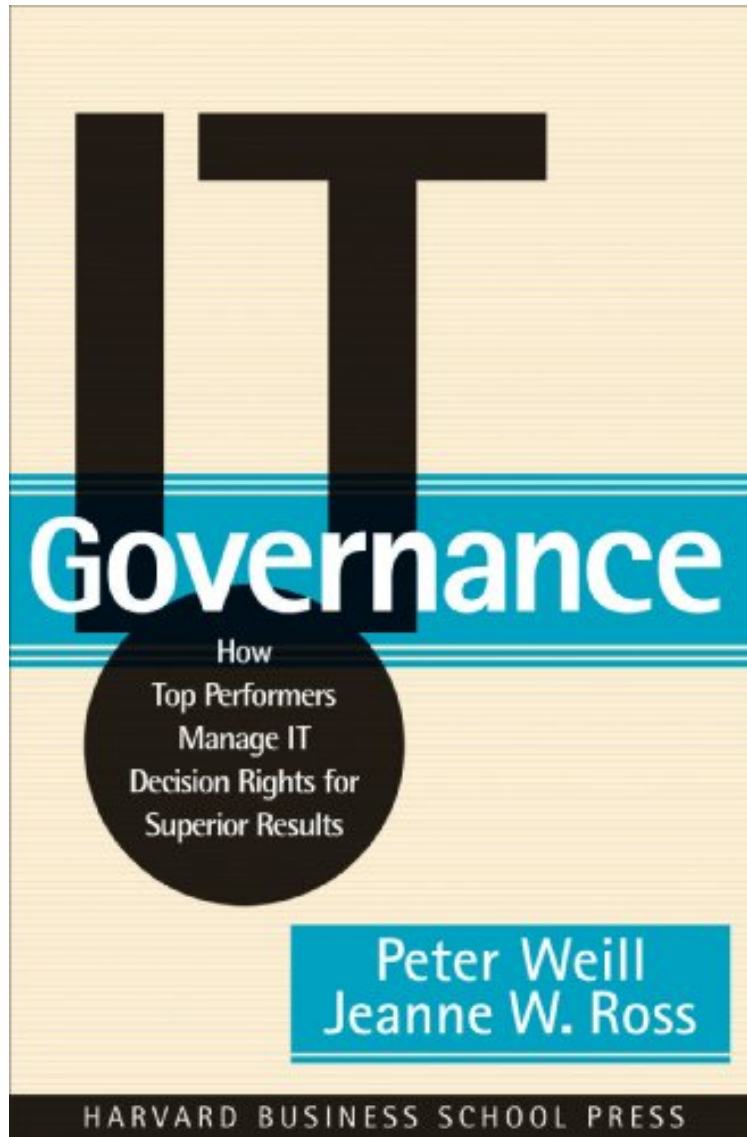

Key point is that not all decisions should be made by the same individuals in the company.
