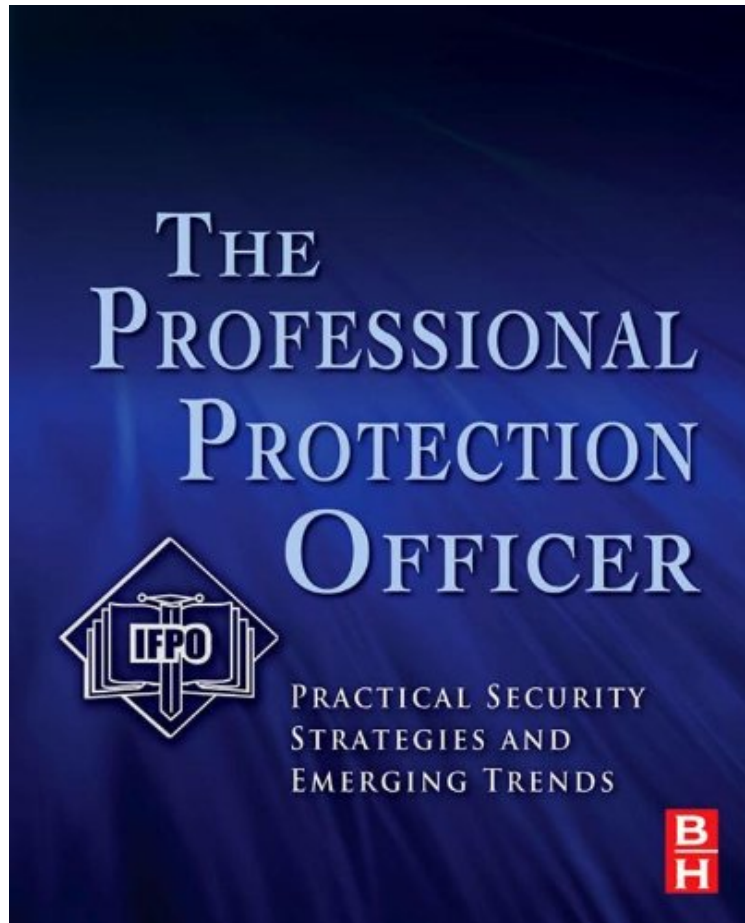

AngellThe International Foundation for Protection Officer's (IFPO) text for their Certified Protection Professional (CPO) designation contains a great deal of information. The information is mostly well presented in manageably brief chapters. Each chapter has a review quiz at the end that is useful in preparing for the CPO examination. However, the answers are nowhere provided in the text. This oversight negates to some degree the value of the end-of-chapter review quizzes. One chapter -- quite confusingly -- had three sets of answers but not the corresponding questions. Finally, the work is a compilation of chapter contributors. It seems, however, that there was no overall editor to reconcile the different chapters. So, there are unnecessary repetitions and sometimes conflicting definitions and descriptions amongst the chapters. With but a little bit of editorial work this good book could be made into an
